

# Political Geography

**Political Geography is the leading journal for political geography and research on spatial dimensions of politics. Themes in the journal also include quantitative methodologies and spatial analyses based on GIS.**

The first issue of the Political Geography Quarterly journal was published in January of 1982 and the journal had the same name until 1991.

Since 1992 it has been published as Political Geography and six issues were published annually instead of four. Eight issues have been published each year since 1995. The journal is published by the Elsevier global company centred in Amsterdam.

The journal is included in reputable bibliographic and citation databases: Current Contents – Social & Behavioural Sciences and Social Sciences Citation Index. In 2010, the journal's impact factor was 1.774, and the five-year impact factor is 2.725. According to impact factor, Political Geography is the 15th among 67 journals in the Geography group.

Full texts of all papers are available to members of Croatian academ-

ic and research community via the PERO browser (<http://lib.irb.hr/utility/pero>).

The journal is also suitable for cartographic content related to political geography. Such content was already mentioned in From Journals columns in this journal (2010, 13, 91; 2011, 15, 185). Here are two additional papers related to cartography:

# Imago Mundi Included in the Thomson Reuters Databases

**Imago Mundi – The International Journal for the History of Cartography is dedicated exclusively to the research of early maps in all of their aspects. It publishes papers related to the history and interpretation of those maps and their production in any part of the world.**

Its brief papers include new knowledge and discoveries. In addition to reviewed papers, there are also book reviews, bibliographies, personal news and information about conferences, institutions, exhibitions and valuable acquisitions. All materials are published in English. The journal has been published since 1935. It was not published regularly until 1975, making its 64th issue published in 2012. The journal was published in the following years: 1935, 1937 and 1939, 1947–1956, 1959–1960, 1962–1972 and 1975–2012. Two issues have been published each

year since 2004. The journal is published by Routledge/Taylor & Francis. The journal's website (<http://www.tandfonline.com/action/aboutThisJournal?journalCode=rimu20>) contains titles of all published articles, as well as paper abstracts in English, French and German (since 1995), as well as Spanish (since 2004).

Via the PERO browser (<http://lib.irb.hr/utility/pero>), members of the Croatian academic and research community have access to full texts of all articles published since 2003, with those published in the last 12 months not available.

Since the first issue published in 2009, the journal has been included in reputable Thomson Reuters bibliographic and citation databases: Social Sciences Citation Index, Art & Humanities Citation Index, Current Contents – Social & Behavioural Sciences and Current Contents – Art & Humanities.

# Political Geography

**Political Geography** je vodeći časopis za političku geografiju i istraživanja o prostornim dimenzijama politike. Među temama koje se u časopisu objavljuju navedene su i kvantitativne metodologije i prostorne analize temeljene na GIS-u.

Prvi broj časopisa *Political Geography Quarterly* objavljen je u siječnju 1982. i pod tim je naslovom izlazio do 1991. Od 1992. izlazi pod naslovom *Political Geography* i

umjesto četiri izlazio je šest puta godišnje. Od 1995. izlazi osam puta godišnje. Izdavač časopisa je globalna kompanija Elsevier sa sjedištem u Amsterdamu.

Časopis je uvršten u ugledne bibliografske i citatne baze: *Current Contents – Social & Behavioral Sciences* i *Social Sciences Citation Index*. Faktor odjeka za 2010. iznosi 1,774, a petogodišnji faktor odjeka je 2,725. U skupini *Geography* među 67 časopisa *Political Geography* prema faktoru odjeka zauzima 15. mjesto.

Cjeloviti tekstovi svih članaka dostupni su članovima hrvatske akademске i istraživačke zajednice preko pretraživača PERO (<http://lib.irb.hr/utility/pero>).

Časopis je prikladan i za kartografske sadržaje s temom političke geografije. Na takve sadržaje već smo skrenuli pozornost čitateljima časopisa *Kartografija* i geoinformacije u prikazima *Iz časopisa* (2010, 13, 91; 2011, 15, 185). Ovdje navodimo još dva članka s kartografskom tematikom:

## uvršten u Thomson Reutersove baze podataka

Časopis *Imago Mundi – The International Journal for the History of Cartography* posvećen je isključivo istraživanju starih karata u svim njihovim aspektima. Objavljuje članke koji se bave poviješću i interpretacijom tih karata te njihovom izradom u bilo kojem dijelu svijeta.

U kratkim člancima prenose se i nove spoznaje i otkrića. Osim recenziranih članaka objavljuju se i prikazi knjiga, bibliografije, osobne vijesti te informacije o konferencijama, institucijama, izložbama i vrijednim akvizicijama. Svi prilozi objavljuju se na engleskom jeziku. Časopis izlazi od 1935. godine. Sve do 1975. nije izlazio redovito svake godine, pa 2012. izlazi 64. godište. Izlazio je u ovim godinama: 1935, 1937, 1939, 1947–1956, 1959–1960, 1962–1972, 1975–2012. Do 2003. izlazio je jedan broj godišnje, a

od 2004. svake godine izlaze dva broja. Izdavač časopisa je *Routledge/Taylor & Francis*. Na mrežnim stranicama časopisa (<http://www.tandfonline.com/action/aboutThisJournal?journalCode=rimu20>) dostupni su naslovi svih objavljenih priloga, a od 1995. i sažeci članaka na engleskom, francuskom i njemačkom jeziku te od 2004. i na španjolskom.

Članovima hrvatske akademске i istraživačke zajednice cjeloviti tekstovi svih priloga dostupni su preko pretraživača PERO (<http://lib.irb.hr/utility/pero>) od 2003. godine s odgodom pristupa najnovijim brojevima od 12 mjeseci.

Od prvoga broja iz 2009. časopis je uvršten u ugledne Thomson Reutersove bibliografske i citatne baze: *Social Sciences Citation Index*, *Art & Humanities Citation Index*, *Current Contents – Social & Behavioral Sciences* i *Current Contents – Art & Humanities*.
